

## MOVIE RENTAL TERMS AND CONDITIONS

1. **Independent Organization:** The Activity Organizer (the Organizer) acknowledges that they are organizing the film showing activity out of their own accord. There is no employee-employer relationship between the Organizer and Silverzeno Entertainment Production (the Company).
2. **Compliances:** The Organizer agrees to remain adherent to:
  - a. The [terms and conditions](#) set for accredited organizers.
  - b. all applicable laws and regulations governing the organization of film showing activities. This includes obtaining any necessary permits or licenses required for the event.
3. **Indemnification:** The Organizer agrees to indemnify and hold the Company harmless from any and all claims, liabilities, damages, and expenses (including reasonable attorney's fees) arising from any unforeseen events such as accidents, injuries, or other issues that may occur during the event.
4. **Payment Terms:**
  - a. 20% of the agreed rates as reservation and downpayment upon booking.
  - b. Remaining balance to be paid in full no later than 3:00pm at least one day prior to the activity date
  - c. Proof of payments must be submitted via email to [admin@silverzeno.com](mailto:admin@silverzeno.com).
  - d. Reservation and downpayment may be applied for events rescheduled within 30 days from the original activity date set by the Organizer. If unused past 30 days from the original date, the reservation and downpayment will be considered forfeited.
  - e. Failure to make timely payments may result in the cancellation of the booking.
5. **Safety and Preventive Measures:** The Organizer warrants to the Company that it follows preventive measures such as proper planning and applying for insurances to protect its attendees from any undesirable events. The Organizer agrees to keep the Company free from any liability arising from such events.
6. **End of Activity Reports:** For educational film showing activities, in compliance with the requirement by the *Department of Education (DepEd)*, the Organizer agrees to accomplish and submit End of Activity and Evaluation Reports provided in the '[Terms and Conditions for Accredited Organizers](#)'.
7. **Cancellation Policy:** Cancellation of events may forfeit the reservation fee made to the Company.
8. **Issued Materials:** The Organizer agrees to keep the materials provided by the Company for the Activity safe and free from damages. These materials include, but are not limited to, flash drives or hard disks, MTRCB Permits, promotional materials, etc., and agrees to return them to the Company in good working condition to **Silverzeno Entertainment** with address at Lot 33 Blk 42 Ph2 Sorrento Village Burgos Rodriguez Rizal and contact number 0939-1439711.
9. **Force Majeure:** Neither party shall be liable for any failure to perform its obligations under this agreement if such failure is caused by circumstances beyond its reasonable control, including but not limited to acts of God, war, terrorism, government orders, or any other force majeure event. In such cases, the affected party shall notify the other party as soon as possible and make reasonable efforts to resume performance.
10. **Dispute Resolution:** Any disputes arising from or in connection with this agreement shall be resolved through mediation or arbitration. If the dispute cannot be resolved through these means, it shall be submitted to the Regional Trial Court (RTC) of San Mateo, Rizal, for resolution.
11. **Confidentiality:** The Activity Organizer understands that rental fees of the movie may vary depending on various factors such as production costs, locations, package inclusions, etc., and hereby agrees to keep the arranged rental fees confidential.
